3. UPDATE ON LIEUTENANT GOVERNOR IN COUNCIL (LGIC) APPOINTMENT

Chair Balsom advised that Rob Nicholson has been officially appointed, subject to the pleasure of the Lieutenant Governor in Council, as a member of the NC Board of Governors, for a period effective October 20, 2022 to August 31, 2025.

7. THE FUTURE OF LEARNING AT NC: LEARNING MANAGEMENT SYSTEM REVIEW AND SELECTION

Vice President of Academic, Fiona Allan and Director of Teaching and Learning Innovation, Natasha Patrito Hannon led the Board in a discussion on the *Future of Learning at NC: Learning Management System Review and Selection*. Highlights of the presentation included:

- The current Learning Management System (LMS), Blackboard Learn Original, has been in use at Niagara College since 2004. In the two decades that followed, learning management systems like Blackboard have become essential tools to support teaching and learning.
- At NC, the LMS is a critical hub for communication, content-sharing, assessment, and feedback with and among students, staff, and faculty.
- Niagara College's current Blackboard license ends in 2024. The college believes that now is the
 right time to bring our community together to discuss our digital learning needs and opportunities,
 identify priorities, and select a LMS platform that will take NC into the future.
- Guiding principles of the system review and selection:
 - o Future-focused
 - Transparent
 - Community input & engagement
 - Centered on user needs & experience
 - Accessible & inclusive
- The college received direct input from over 1100 NC community members, including 500 students through consultation initiatives.
- Additional details regarding the LMS review process and activities to date can be accessed at the college's LMS Review website.

8. MID-YEAR UPDATE (COLLEGE GOALS)

Senior Vice-President of College Operations, Pam Skinner provided a mid-year update on the progress made to date on the annual operational goals. Highlights included:

Launch new programs and grow enrolments

 Added winter intakes in high demand programs: Social Service Worker and Office Administration -Medical

Ensure all programs meet or exceed the college quality assurance audit process (CQAAP) standards

Achieved "mature" status in CQAAP audit

Enhance teaching and learning technologies and systems to better support flexible learning and access to digital resources

 Comprehensive Learning Management System Review is underway, with over 1,000 responses to consultation

Strengthen alumni and donor engagement

- Multi-year alumni engagement strategy presented to the Board in October 2022
- Hosted 682 participants at the on-campus Virtual-Graduate Reunion Celebration in October
- Event to unveil the Saundra Patterson Memorial Garden occurred in October. Community donors contributed a total of \$89,000 to the garden project and the Saundra Patterson Horticultural Bursary

Foster a culture of innovation

Dream Big fund launched in June 2022

Grow our people and college community

- Management Success, a management development program, launched in November
- Niagara Day, the college's annual celebration of employee achievements, was held in-person in October, with over 400 employees in attendance

Nurture and develop a culture of equity, diversity & inclusion

EDI Blueprint drafted, with specific actions already underway; expected launch in January 2023

Create vibrant campuses, learning and student spaces

- Master Plan is being updated to reflect new Strategic Plan
- Piloting new workspace configurations in response to remote work policy

Improve student engagement and communications

- Centre for Student Engagement and Leadership (CSEL) has been repositioned with Athletics and Recreation for greater collaboration and institutional focus
- An RFP for a student engagement app is currently under development

Increase on-campus housing opportunities

 Procuring student housing consulting services prior to finalizing the Niagara College Student Housing Request for Proposal (RFP)

Bolster opportunities for students to engage with and support local and global communities

- Massage Therapy clinic students offer reduced-cost treatments to the local community
- Be World Ready study abroad trips recommenced in Fall 2022, with 60 participants travelling to Ireland and Costa Rica on three unique academically-focused programs

Diversify revenue streams to ensure financial sustainability and enable strategic investments to support students, academic excellence and innovation

- Secured funding to deliver additional programming in the School of Trades and Early Childhood Education program to increase access for non-traditional learners
- Exceeded enrolment and revenue targets for Niagara College Toronto

9. NEXT GENERATION GREENHOUSE

Senior Vice President of College Operations, Pam Skinner provided a presentation on the college's plans for a Next Generation Greenhouse. Highlights of the presentation include:

- Concept began in 2017 as replacement of current Greenhouse with a new build on the escarpment side of the road into campus. College management began exploring and lobbying various funding sources.
- 2019/20: College decided to build a new Greenhouse on existing location to reduce costs. Design and costing work began, pace significantly slowed due to pandemic.
- 2020/21: College continued to work on design and seeking funding as costs escalated.
- 2022: College decided to build a separate Next Generation Greenhouse adjacent to the current Greenhouse to avoid suspension of program for construction.
- The new greenhouse will enable:
 - o Multiple, controlled experiments/ projects in smaller spaces
 - Improved handling of samples and diminished cross contaminations via self-contained lab space
- It is expected more than 125 students per year will participate in applied research projects, including course-based projects.
- NC's reputation will be enhanced as a top research college in Canada and further demonstrate industry engagement excellence.
- The Next Generation Greenhouse will not replace the current greenhouse but will be adjacent to it.
- Total cost of \$9.4M will be offset by government funding of \$3.3M for construction.
- Project completion is anticipated by March 2024.

10. REVISIONS TO BOARD POLICY IV.F: PROCUREMENT AND PROTECTION OF RESOURCES

Senior Vice President of College Operations, Pam Skinner and Senior Director of Finance, Vince Malvaso presented the proposed revisions to Board Policy IV.F: Procurement and Protection of Resources.

People leader nomenclature changes were implemented August 2, 2022, to create consistent alignment between job classifications and position titles and to better reflect the nature of the roles. As a result of the nomenclature changes, the Approval Authority Schedule (AAS) is to be updated to remove the duplication and compression within the existing AAS.

Further to the nomenclature updates to the AAS, a review of procurement activities and trends over the past 5 years has been completed to assess the existing approval thresholds to current College operations.

The proposed revisions to the Board policy includes the recommended changes to the AAS to better reflect the accountabilities at the different administrative levels.

11. <u>HONOURS BACHELOR OF BUSINESS ADMINISTRATION (INTERNATIONAL COMMERCE AND GLOBAL DEVELOPMENT) PROGRAM</u>

Vice President of Academic, Fiona Allan provided an update on the Honours Bachelor of Business Administration (International Commerce and Global Development) program.

Ontario Colleges require ministerial consent to offer degree programs. Facilitated through the Postsecondary Education Quality Assessment Board (PEQAB), the consent process is an intensive analysis of the program, student achievement, and outcomes, and results in recommendations and ultimately approval to continue offering the credential. This process happens once every five to seven years.

During the last two consent renewals for the Honours Bachelor of Business Administration International Commerce & Global Development Degree (BBA-ICOM), launched in 2006, challenges were identified with the program focus and outcomes, student expectations, employment prospects and historically low enrolment. These concerns were supported during the most recent review in 2021, which led to conversations on program viability and relevance in today's labour market.

A further examination of the data and meetings with PEQAB were conducted in 2022 and determined that significant revisions to the program outcomes were needed, necessitating an overhaul of courses and program structure essentially leading to the submission of a new credential. Financial analysis showed the program was not able to break even due to low enrolment. In 2022, the applicant pool had decreased to four students, which led to the suspension of the Fall level one intake while the analysis continued. There are no applicants to redirect, and no applications currently being accepted at OCAS.

After much consideration, it is recommended that the BBA-ICOM be cancelled. Students currently enrolled would continue for program completion, as per the binding policy. Resources, including the expertise of program staff, will be refocused, with the intent of creating new credentials more relevant and necessary for students entering today's labour market. Currently two concepts have been put forward for consideration: International Affairs & Global Development Graduate Certificate and a Global Sustainable Business Graduate Certificate.

12. UPDATE ON NC INTERNATIONAL

Vice President of International, Sean Coote provided an update on NC International initiatives. Highlights of the presentation include:

Niagara College Toronto (NCT):

- The completion of NCT's permanent location in Mirvish Village, in downtown Toronto, is expected in winter 2023.
- Enrolment growth is planned to level out around 6,000 students by 2023F, with diversity being a key focus.
- The Committee of Presidents has developed a guiding principle document to provide standards with respect to the recruitment of international students and associated supports.

NC KSA Update:

- Current deliveries include the Makkah Female Campus, Leading National Academy and the Tayaran Aviation Academy.
- Strong business development and significant funding increases will have good growth for 2023 and beyond.
- Resolution process underway related to withholding and income tax reassessment moving forward with KPMG support.

Governors requested that the draft Standards of Practice for International Education, drafted with the assistance of Colleges Ontario, be shared with the Board.

13. 2022/23 BOARD OF GOVERNORS GOALS

Vice Chair Caroline Mann (Chair of the Board's Priorities & Planning Committee) presented the committee's recommendation for the 2022/23 Board of Governors Goals.

Governors suggested that in future years, the Board consider adopting specific and actionable goals that are in addition to the inherent fiduciary responsibilities of Board members.

- The 2022 Higher Education Summit occurred on November 26 & 27, 2022. The event was a tremendous opportunity to discuss many of the issues affecting post-secondary education today.
- Two Niagara College alumni were named winners of the Premier's Awards
